

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Department of Health and Human Services, Division  
of Behavioral Health, FY2006 The Safe and Bright Futures for Children Initiative  
Planning Grant and Budget Amendment/Modification #1, Account No. 11-1482)**

**RESOLUTION NO. 06-393**

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**  
2 **substance abuse and mental health services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application for this project in August**  
4 **2004; and**

5 **WHEREAS, the Safe and Bright Futures, Domestic Violence for Children and Adolescent Planning**  
6 **Grant is a planning and design process for a comprehensive system that will reduce**  
7 **violence against children, adolescents and provide direct service for the children,**  
8 **adolescents, and their families; and**

9 **WHEREAS, the Notice of Award was received for Fiscal Year 2005 in the amount of \$75,000.00 for**  
10 **the first year of a two-year grant; and**

11 **WHEREAS, this amendment/modification #1 will delete the Grant Project Manager effective June**  
12 **5, 2006, and transfer the salary to the Targeted Capacity Expansion Project to Increase**  
13 **Early Intervention Services for Adolescents Grant, Account No. 11-1481; and**

14 **WHEREAS, increase line item Travel Expense for travel and line item Professional Services for**  
15 **evaluation services to assist with the completion of the required Comprehensive Plan;**  
16 **and**

17 **WHEREAS, the original budget reflected 17.1% in indirect costs; this amendment/modification**  
18 **#1 reflects the increase of the current indirect cost rate of 17.98%; and**

19 **WHEREAS, the Safe and Bright Future, Domestic Violence for Children and Adolescents Planning**  
20 **Grant and budget amendment/modification #1 in the amount of \$75,000 for Year Two**  
21 **of the two-year grant are hereby submitted for review and approval by the Tohono**  
22 **O'odham Legislative Council.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

24 **1. Hereby approves and authorizes expenditures in accordance with the Department**  
25 **of Health and Human Services, Division of Behavioral Health FY 2006 The Safe and**  
26 **Bright Future, Domestic Violence for Children and Adolescent Planning Grant and**  
27 **attached budget amendment/modification #1 in the amount of \$75,000 for the**  
28 **second year of a two-year grant, modified as follows:**



- 7                   4. The original budget reflected 17.1% in indirect costs; this amendment/
- 8                   modification #1 reflects the increase of the current indirect cost rate of 17.98%.

9 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
10 Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official  
11 are authorized to negotiate and execute the grant, provided however, that any  
12 amendments/modifications affecting the funds or funding levels of the grant shall be  
13 submitted for further prior approval by the Tohono O'odham Legislative Council.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> Day  
15 of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;  
16 -0- NOT NOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)  
17 and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
20 Stat. 984).


