

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2006 Budget Amendment No. 3 for the Tohono O'odham Nation Police**  
**Department 638 BIA Contract for Increase in Base Funding of \$521,781.00 (BIA Mod 12**  
**and BIA Mod 13) Under Account No. 10-1090)**

**RESOLUTION NO. 06-398**

1 **WHEREAS, the Tohono O'odham Nation under the 638 BIA Master Contract contracts its own Law**  
2 **Enforcement, Corrections and Ranger Programs; and**

3 **WHEREAS, TONPD has received an increase in base funding of \$521,781.00 to be utilized for**  
4 **program needs; and**

5 **WHEREAS, TONPD has identified those needs to provide for training and registration; to purchase**  
6 **rifles, night vision goggles, ballistic vests; tactical vests, ammunition, vehicles**  
7 **including police accessories, ATV's and trailers; and**

8 **WHEREAS, in order to purchase such equipment and supplies two account numbers need to be**  
9 **established 10-1090-650-Tuition & Registration to provide for training and 10-1090-**  
10 **728-Ammunition to purchase ammunition for usage by swat teams; and**

11 **WHEREAS, under the FY 2006 BIA 638 Law Enforcement Budget account no. 10-1090 there are no**  
12 **line items for 650-Tuition and Registration and 728-Ammunition; and**

13 **WHEREAS, to establish a new position of Systems Administrator to maintain software programs**  
14 **that are crucial to police information.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**  
16 **hereby approves and authorizes Budget Amendment No. 3 for addition to base funding**  
17 **of \$521,781.00 for TONPD Law Enforcement BIA 638 Budget account no. 10-1090.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **establishment of line items 660-Tuition and Registration and 730-Ammunition.**

20 **BE IT FURTHER RESOLVED the approval and authorization of the new position of Systems**  
21 **Administrator.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Vice Chairman is hereby authorized**  
23 **to negotiate and execute the budget provided that any amendments affecting the**  
24 **funding or funding levels of this budget shall be submitted for approval to the Tohono**  
25 **O'odham Nation Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> Day**  
27 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,852.4 FOR; 588.4**  
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
30 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**


