

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving BIA 638 Contract of Carry Over Savings of \$200,000.00 and an Additional Allocation of \$743,718.00 in Recurring Funds for the Tohono O'odham Nation Police Department Corrections Program and Approving FY 2006 Budget Amendment #1 in Establishing Line Items 680, 720, 721, 723 and 770 under Account No. 10-1093)**

RESOLUTION NO. 06-399

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Corrections and**
2 **Ranger Programs for Public Safety Services under the 638 Bureau of Indian Affairs**
3 **Master Contract; and**

4 **WHEREAS, the TONPD Corrections Program has carry over savings of \$200,000.00 (one-time)**
5 **specifically to be used for equipment needs of the new Facility; and**

6 **WHEREAS, an additional allocation funding for the New Corrections Facility is to be recurring**
7 **each fiscal year in the amount of \$743,718.00; and**

8 **WHEREAS, TONPD needs to add in the amount of \$873,370.19 to base which includes the carry-**
9 **over savings and the additional allocation for the Corrections Program; and**

10 **WHEREAS, the Corrections Program has identified the needs to staff the new Corrections**
11 **Facilities, provide for supplies and equipment for operations; and**

12 **WHEREAS, these funds are to be utilized for recruitment expenses; salaries, other compensation**
13 **and fringe benefits for thirty-four (34) new Corrections staff consisting of: 23**
14 **Corrections Officers; 1 Corrections Specialist; 5 Corrections Sergeant; 1 Certified**
15 **Substance Abuse Specialist; 1 Receptionist; 1 Maintenance Engineer III and 2 Building**
16 **& Grounds Worker; and**

17 **WHEREAS, the need to supply the new Corrections Staff with office supplies and equipment, new**
18 **uniforms and RM of equipment to operate the new facilities; and**

19 **WHEREAS, under the BIA 638 Corrections Program for FY 2006 there are no line items for 680-**
20 **Recruitment Expense; 720-Supplies-Office; 721-Supplies-Other; 723-Uniform and 770-**
21 **RM Equipment; and**

22 **WHEREAS, these lines items need to be created in order for the new Corrections Facility to**
23 **operate.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
25 **accepts, approves and authorizes FY 2006 Budget Amendment #1 of \$873,370.19**
26 **consisting of carry over savings of \$200,000.00 as one-time funding and additional**
27 **allocation to be recurring funds of \$743,718.00.**


1 **BE IT FURTHER RESOLVED** that the additional allocation is to be recurring each fiscal year for the
2 operations of the new Corrections Facility.

3 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council approves the
4 establishment of new line items to operate the new Corrections Facilities under
5 account number 10-1093 for 680-Recruitment Expense; 720-Supplies-Office; 721-
6 Supplies-Other; 723-Uniforms and 770-RM Equipment.

7 **BE IT FINALLY RESOLVED** that the Tohono O'odham Nation Vice Chairman is hereby authorized
8 to negotiate and execute the budget provided that any future amendments affecting
9 the funding or funding levels of this budget shall be submitted to the Tohono O'odham
10 Legislative Council.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day
12 of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,080.3 FOR; -0- AGAINST;
13 -0- NOT VOTING; and 360.5 [06] ABSENT, pursuant to the powers vested in the Council by Section
14 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
15 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17 18, 1934 (48 Stat. 984).
