RESOLUTION NO. 06-400

1 **WHEREAS, the State of Arizona Governor's Office for Children, Youth and Families, Division for**
2 **Substance Abuse Policy (GOCYF/DSAP), 06-6364-18, has announced a Arizona Anti-**
3 **Meth Initiative Planning Grant award of \$20,000.00 to the Behavioral Health Division**
4 **under the Tohono O'odham Department of Health and Human Services to implement**
5 **the requirements of this planning award; and**

6 **WHEREAS, the Arizona Anti-Meth Initiative Planning Grant and budget in the amount of**
7 **\$20,000.00 are hereby submitted for acceptance and approval by the Tohono O'odham**
8 **Legislative Council; and**

9 **WHEREAS, the Anti-Meth Initiative Planning Grant is a cost reimbursement award to have a**
10 **working diverse Anti-Meth coalition working group to develop a plan on how to bring**
11 **awareness, education and so forth to the communities of the Nation about the**
12 **damaging effects of this dangerous drug; and**

13 **WHEREAS, the Behavioral Health Division under the Department of Health and Human Services**
14 **will follow the allowable cost for this Anti-Meth Initiative Planning Grant Award for**
15 **reimbursements for the amount of \$20,000.00; and**

16 **WHEREAS, the Anti-Meth Award Initiative in the amount of \$20,000.00 for FY2006, has been**
17 **submitted for review and approved by the Department of Health and Human Services,**
18 **for the Behavioral Health Division.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts,**
20 **approves and authorizes expenditures in accordance with the Department of Health**
21 **& Human Services, Division of Behavioral Health, The State of Arizona Governor's**
22 **Office for Children, Youth and Families, Division for Substance Abuse Policy**
23 **(GOCYF/DSAP), 06-6364-18, Anti-Meth Initiative Planning Grant and attached budget**
24 **in the amount of \$20,000.00.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
27 **are authorized to negotiate and execute the grant, provided however, that any**
28 **amendments affecting the funds or funding levels of the grant shall be submitted for**
29 **further prior approval by the Tohono O'odham Legislative Council.**
