

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approves Employment Assistance Program FY 2006 Budget Amendment/Modification
1 - Account # 10-1206)

RESOLUTION NO. 06-405

1 **WHEREAS, the Tohono O'odham Nation through the Employment Assistance Program has been**
2 **successfully providing counseling and financial assistance to eligible Tohono**
3 **O'odham to attend Post secondary Institutes; and**

4 **WHEREAS, the Employment Assistance Program, through the Grants and Contracts Office, has**
5 **received the BIA's FY 2006 Allocation a total of \$305,275.00; and**

6 **WHEREAS, through the Grants and Contracts Office notified the Program FY 2005 Carry forward**
7 **of \$12,143.57; and**

8 **WHEREAS, the Employment Assistance Program Amendment/Modification #1 reflects an**
9 **increase in line item 626 allowance & Stipend and line item 662 mileage (GSA); and**

10 **WHEREAS, the Employment Assistance Program Amendment/Modification #1 reflects a decrease**
11 **in line item 660 Travel Expense for a new total of \$1,000.00; and**

12 **WHEREAS, the Employment Assistance Program Amendment/Modification # 1 adds a new line**
13 **item 771 Repair and Maintenance-Vehicle; and**

14 **WHEREAS, the FY 2006 Employment Assistance Program Amendment/Modification # 1 reflects**
15 **change in indirect cost from 17.79% to 17.98%.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **Employment Assistance Program Budget Amendment/Modification #1 reflecting the**
18 **FY 2006 Allocation increase of \$12,038.00 and FY 2005 Carry forward funds of**
19 **\$12,143.57, with an increase FY 2006 budget from \$331,591.84 to \$357,187.18**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and authorizes**
21 **the Employment Assistance Program Modification/Amendment #1 with an additional**
22 **new line item, 771 Repair and Maintenance-Vehicle.**

23 **BE IT FURTHER RESOLVED that the Employment Assistance Program Modification/Amendment**
24 **#1 reflects an increase in indirect cost from 17.85% to 17.98% and an increase in line**
25 **item 626 Allowance & Stipend and line item 662 Mileage and decrease line item 660**
26 **Travel Expense.**



5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
6 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,060.3 FOR; -0-**
7 **AGAINST; 380.5 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
8 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
9 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
11 **18, 1934 (48 Stat. 984).**


