

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Tohono O'odham Nation Recreation Division FY 2006 Budget Modification #2,**  
**and Supplement Appropriations of \$270,000.00)**

**RESOLUTION NO. 06-409**

1 **WHEREAS, the Tohono O'odham Nation Recreation Division has brought forth a Budget**  
2 **Modification to its FY 2006 budget; and**

3 **WHEREAS, in Resolution No. 05-582 the Tohono O'odham Legislative Council approved the FY**  
4 **2006 Tohono O'odham Nation Recreation Division in the amount of \$3,072,512.38;**  
5 **and**

6 **WHEREAS, the Tohono O'odham Nation Recreation Division is requesting \$270,000.00 from the**  
7 **General Funds to cover the perimeter fencing costs of each center, and to assist in**  
8 **covering costs to pay an outstanding bill from Climatec, BTG; and**

9 **WHEREAS, the Tohono O'odham Nation Recreation Division has also submitted for review and**  
10 **approval the proposed FY 2006 Budget Modification, which decreases line item**  
11 **number 710-Utilities; decreases line item number 774-Computer Maintenance; and**  
12 **decrease line item number 810-Professional Services; and**

13 **WHEREAS, the Tohono O'odham Nation Recreation Division has submitted for review and**  
14 **approval the proposed FY 2006 Budget Modification, which adds to line item 750-**  
15 **Major Capital Equipment for \$270,000.00 from General Funds; and**

16 **WHEREAS, the Tohono O'odham Nation Recreation Division has submitted for review and**  
17 **approval the proposed FY 2006 Budget Modification, which increases line item 721-**  
18 **Supplies Other by \$110,000.00 from 710-Utilities savings; increases line item 722-**  
19 **Program Supplies by \$60,000.00, from a combined \$20,000.00 from 710-Utilities;**  
20 **\$20,000.00 from 774-Computer Maintenance; and \$20,000.00 from 810-Professional**  
21 **Services savings; increases line item 860-Special Activities by \$10,000.00 from 810-**  
22 **Professional Services savings; and**

23 **WHEREAS, the Human Resources Development Committee and Budget & Finance Committee**  
24 **have reviewed FY 2006 Tohono O'odham Nation Recreation Division Budget**  
25 **Modification #2, which is hereby incorporated by this reference, and recommends**  
26 **approval.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby (1)**  
28 **approve the Tohono O'odham Recreation Division FY 2006 Budget Modification #2,**



1 (2) appropriates \$270,000.00 from the general fund to supplement the Tohono  
2 O'odham Nation Recreation Division FY 2006 Budget, which increases FY 2006  
3 Recreation Division budget for a total budget amount of \$3,342,512.38.

4 **BE IT FINALLY RESOLVED** that the Tohono O'odham Nation Legislative Council that the Tohono  
5 O'odham Nation's Officials, to wit; the Chairwoman and Vice Chairman and any  
6 designated Official are authorized to negotiate and execute this budget, provided  
7 however, that any amendment affecting the funds or funding levels of this budget  
8 shall be submitted for further prior approval by the Tohono O'odham Legislative  
9 Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day  
11 of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,254.1 FOR; -0- AGAINST;  
12 186.7 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section  
13 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
14 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
16 Stat. 984).




