

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Range Conservation and Management Program Budget Amendment #2
to add \$973.74 of Indirect Cost to the FY 06 Budget 10-1513 to increase the budget
to \$950,950.07)

RESOLUTION NO. 06-411

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY06 Range Conservation and**
2 **Management Program budget 10-1513, under the PL 93-638 Master Contract, with**
3 **Resolution 05-590; and**

4 **WHEREAS, the FY06 Range Conservation and Management Program budget's indirect cost was**
5 **calculated at 17.79%; and**

6 **WHEREAS, the Nation's indirect cost is paid through the PL 93-638 Master Contract-contract**
7 **support funds, which are separate from the funds used for the budget base allocation;**
8 **and**

9 **WHEREAS, during FY06, the Nation's indirect cost increased to 17.98%; and**

10 **WHEREAS, the Range Conservation and Management Program is requesting that the Tohono**
11 **O'odham Legislative Council approve an increase in the indirect cost, in the amount**
12 **of \$973.74, to the FY06 budget 10-1513; and**

13 **WHEREAS, the FY06 Range Conservation and Management Program budget 10-1513 has been**
14 **reviewed by the Tohono O'odham Legislative Agricultural and Budget and Finance**
15 **Committees.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves the increase in the indirect cost to 17.98%, in the amount of \$973.74, to the**
18 **FY06 Range Conservation and Management Program budget 10-1513, to increase the**
19 **budget to \$950,950.07, in accordance with the budget attached hereto.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated**
22 **official are authorized to administer the budget, provided however, that any**
23 **amendments affecting the funds or funding levels of the budget shall be submitted**
24 **for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
26 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,273.4 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and 167.4[06] ABSENT, pursuant to the powers vested in the Council by Section**
28 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
