RESOLUTION NO. 06-412

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2006 Water Resources Study**
2 **Program SAWRSA budget 21-1525 with Resolution No. 05-555; and**

3 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2007 Water Resources Study**
4 **Program SAWRSA budget 21-1525 with Resolution No. 06-170; and**

5 **WHEREAS, the funding for the SAWRSA budget 21-1525 comes from the SAWRSA Trust Fund**
6 **through Resolution No. 04-688; and**

7 **WHEREAS, this resolution amends Tohono O'odham Legislative Council Resolution No. 06-170 for**
8 **the FY2007 budget amount of \$1,032,735.00; and**

9 **WHEREAS, the Water Resources Study Program has begun an intensive drilling program on the**
10 **Nation and would like to continue this drilling program until all funds for drilling are**
11 **exhausted; and**

12 **WHEREAS, the Water Resources Study Program requests that \$259,556.22 be transferred from the**
13 **FY2007 SAWRSA budget 21-1525 810 PROFESSIONAL SERVICES line item and**
14 **transferred to the FY2006 SAWRSA budget 21-1525 810 PROFESSIONAL SERVICES line**
15 **item, leaving a balance in the FY2007 SAWRSA budget 21-1525 of \$773,178.78; and**

16 **WHEREAS, this budget amendment has been reviewed by the Legislative Water Resources**
17 **Committee and the Legislative Budget and Finance Committee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 19 **1. amends the Tohono O'odham Legislative Council Resolution No. 06-170 for the**
20 **FY2007 budget amount of \$1,032,735.00; and**
- 21 **2. authorizes the transfer of funds from the FY2007 Water Resources Study Program**
22 **SAWRSA budget 21-1525, in the amount of \$259,556.22, to the FY2006 Water**
23 **Resources Study Program SAWRSA budget 21-1525, leaving a balance of**
24 **\$773,178.78, in accordance with the budget attached hereto; and**
- 25 **3. authorizes the transfer of funds to the FY2006 Water Resources Study Program**
26 **SAWRSA budget 21-1525, in the amount of \$259,556.22, for a total of \$2,558,230.58**
27 **from the FY2007 Water Resources Study Program SAWRSA budget 21-1525.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated official**



4 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day
5 of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,273.4 FOR; -0- AGAINST;
6 -0- NOT VOTING; and 167.4 [06] ABSENT, pursuant to the powers vested in the Council by Section
7 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
8 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
9 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
10 18, 1934 (48 Stat. 984).


