3	"Attorneys") to provide legal representation to the Nation related to the Cultura
4	Center/Museum Project for fiscal year 2006; and
5	WHEREAS, the Cultural Center/Museum Project requires continuing legal representation related
6	to the governance and operations of the <i>Himdag Ki: Hekĭhu, Hemu, Im B I-Ha'ap</i> , the
7	Tohono O'odham Nation Cultural Center & Museum; and
8	WHEREAS, the foregoing legal services required of the Attorney will exceed the amount of the
9	current contract; and
10	WHEREAS, attached hereto is Amendment 1 to the current Attorney Contract in the amount of
11	\$7,500 for fiscal year 2006; and
12	WHEREAS the Cultural Center/Museum Project Account 50-1516-810 has sufficient funds to cover
13	the amount of the amendment; and
14	WHEREAS, the Cultural Preservation, Domestic Affairs and Budget & Finance Committees
15	recommend approval of the Attorney Contract.
16	NOW, THEREFORE, BE IT RESOLVED THAT:
17	1. The Legislative Council approves Amendment 1 to the Attorney Contract with the
18	law firm of Brauchli & Brauchli, P.C. in the amount of \$7,500, increasing the total
19	amount of the contract from \$7,500 to \$15,000 for the period ending September 30
20	2006.
21	2. Funding of Amendment 1 to the Attorney Contract shall be provided from the
22	Cultural Affairs/Museum Budget (Account No. 50-1516-810).
23	3. The Chairwoman of the Nation is authorized and directed to execute the Attorney
24	Contract.
