

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an extension of the Native American/Native Hawaiian Museum Services grant MN-00-05-0034-05 from the Institute of Museum and Library Services to the Cultural Center and Museum Project from March 31, 2006 to December 31, 2006)**

**RESOLUTION NO. 06-416**

1 **WHEREAS, the Tohono O'odham Nation's Legislative Council approved the Native American and**  
2 **Native Hawaiian Museum Services grant MN-00-05-0034-05 for \$16,690.00 from the**  
3 **Institute of Museum and Library Services to the Nation's Cultural Center and Museum**  
4 **with Resolution No. 05-636; and**

5 **WHEREAS, the Native American and Native Hawaiian Museum Services grant will be used to**  
6 **provide a cornerstone publication describing the history, culture and language of the**  
7 **Tohono O'odham using the narratives of 16 members of the Nation sharing their**  
8 **thoughts about the Cultural Center and Museum; and**

9 **WHEREAS, the original end date of the Native American and Native Hawaiian Museum Services**  
10 **grant was March 31, 2006 and the Institute of Museum and Library Services has**  
11 **approved an extension request by the Cultural Center and Museum Project staff to**  
12 **December 31, 2006 without any additional funds; and**

13 **WHEREAS, the extension request by the Cultural Center and Museum staff has been reviewed by**  
14 **the Tohono O'odham Legislative Cultural Preservation Committee and the Legislative**  
15 **Budget and Finance Committee.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
17 **the extension of the ending date of the Native American and Native Hawaiian Museum**  
18 **Services grant MN-00-05-0034-05 from March 31, 2006 to December 31, 2006.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**  
21 **are authorized to administer the grant, provided however, that any modifications or**  
22 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
23 **further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
25 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,705.5 FOR; -0- AGAINST;**  
26 **567.9 NOT VOTING; and 167.4 [06] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**


