

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 to add \$40,500.00 from the General Surplus to the FY2006
Rodeo and Fair Committee budget 01-2005 to increase the budget to \$238,987.00)**

RESOLUTION NO. 06-420

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2006 Rodeo and Fair**
2 **Committee budget 01-2005 with Resolution 05-558; and**

3 **WHEREAS, the Nation's Executive Office has allocated a General Surplus of \$40,500.00 for the**
4 **FY2006 Rodeo and Fair Committee budget 01-2005; and**

5 **WHEREAS, line items 630 INSURANCE, 771 RM VEHICLES, and 750 CAPITAL EQUIPMENT will be**
6 **added to the FY2006 Rodeo and Fair budget; and**

7 **WHEREAS, \$40,500.00 from the General Surplus will be added to the above budget line items and**
8 **712 GAS, OIL, and COOLANTS for a total budget amendment of \$238,987.00; and**

9 **WHEREAS, the FY2006 Rodeo and Fair Committee budget 01-2005 has been reviewed by the**
10 **Tohono O'odham Legislative Commerce Committee and the Legislative Budget and**
11 **Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 13 **1. Approves the creation and addition of the 630 INSURANCE and 771 RM VEHICLES**
14 **line items on an annual recurring to the Rodeo and Fair Committee budget 01-**
15 **2005.**
- 16 **2. Approves the creation and addition of the 750 CAPITAL EQUIPMENT line item to**
17 **the Rodeo and Fair Committee budget 01-2005 on a one-time basis for FY2006.**
- 18 **3. Authorizes the appropriation and expenditure of the General Surplus, in the**
19 **amount of \$40,500.00, on a one-time basis for FY2006, to the FY2006 Rodeo and**
20 **Fair Committee budget 01-2005, for a total budget amendment of \$238,987.00, in**
21 **accordance with the budget attached hereto.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated official**
24 **are authorized to administer the budget, provided however, that any amendments**
25 **affecting the funds or funding levels of the budget shall be submitted for further**
26 **prior approval by the Tohono O'odham Legislative Council.**


