5	WHEREAS, line item 750 CAPITAL EQUIPMENT will be added to the FY2006 Miss Tohono O'odham
6	Nation budget; and
7	WHEREAS, \$30,000.00 from the General Surplus will be added to the above budget line item and
8	660 TRAVEL EXPENSE, 712 GAS, OIL, and COOLANTS and 771 RM VEHICLES for a total
9	budget amendment of \$64,129.00; and
10	WHEREAS, the FY2006 Miss Tohono O'odham Nation budget 01-2004 has been reviewed by the
11	Tohono O'odham Legislative Human Resources Development Committee and the
12	Legislative Budget and Finance Committee.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
14	1. Approves the creation and addition of the 750 CAPITAL EQUIPMENT line item to
15	the Miss Tohono O'odham Nation budget 01-2004 on a one-time basis for FY2006.
16	2. Authorizes the appropriation and expenditure of the General Surplus, in the
17	amount of \$30,000.00, on a one-time basis for FY2006, to the FY2006 Miss Tohono
18	O'odham Nation budget 01-2004, for a total budget amendment of \$64,129.00, in
19	accordance with the budget attached hereto.
20	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
21	Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated official
22	are authorized to administer the budget, provided however, that any amendments
23	affecting the funds or funding levels of the budget shall be submitted for further prior
24	approval by the Tohono O'odham Legislative Council.
