

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment #1 to the FY 2006 District Water Advisory Committee  
Budget Account 21-2021)**

**RESOLUTION NO. 06-422**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2006 District Water**  
2 **Advisory Committee budget 21-2021 with Resolution 05-556; and**

3 **WHEREAS, the District Water Advisory Committee is adding new line items: 710- UTILITIES, 711-**  
4 **COMMUNICATION EXPENSE, and 751-LEASE/RENTAL to the FY 2006 District Water**  
5 **Advisory Committee budget 21-2021; and**

6 **WHEREAS, the FY 2006 District Water Advisory Committee budget 21-2021 has been reviewed by**  
7 **the Tohono O'odham Legislative Water Resources and the Budget and Finance**  
8 **Committees; and**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **approves the addition of new line items 710- UTILITIES, 711-COMMUNICATION**  
11 **EXPENSE, and 751-LEASE/RENTAL to the annual recurring District Water Advisory**  
12 **Committee budget 21-2021, in accordance with the modified budget attached hereto.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
14 **Nation's Officials to wit: the Chairwoman, Vice Chairman, and any designated official**  
15 **are authorized to administer the budget, provided however, that any amendments**  
16 **affecting the funds or funding levels of the budget shall be submitted for further prior**  
17 **approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
19 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,896.75 FOR; 221.6**  
20 **AGAINST; 129.35 NOT VOTING; and 193.1 [06] ABSENT, pursuant to the powers vested in the**  
21 **Council by Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham**  
22 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
23 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
24 **of the Act of June 18, 1934 (48 Stat. 984).**


