16	affecting the funds or funding levels of the budget shall be submitted for further prior
17	approval by the Tohono O'odham Legislative Council.

21	Council by Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham

23	Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
	of the Act of June 18, 1934 (48 Stat. 984).
