(Approving Amendment No. 1 to the P.L. 93-638 Construction Contract and the Joint Venture Construction Program Agreement for the Westside/San Simon Health Center)

1	WHEREAS, in May 2000 the Tohono O'odham Nation ("Nation") entered into a Public Law 93-638
2	Subpart J Construction Contract with the Indian Health Service to allow the Nation to
3	use \$350,000 in federal funds in the construction of the \$11,000,000 Westside (now San
4	Simon) Health Center (the "San Simon Health Center"); and
5	WHEREAS, on or about May 22, 2003 the Nation entered into a Joint Venture Construction
6	Program Agreement with the Indian Health Service to provide for the construction,
7	staffing, equipping and operation of the San Simon Health Center; and
8	WHEREAS, the Nation and the Indian Health Service have agreed to address certain financial
9	issues which have arisen during the construction of the San Simon Health Center in
10	an Amendment No. 1 to both the P.L. 93-638 Subpart J Construction Contract and the
11	Joint Venture Agreement, which is attached to this resolution and incorporated herein
12	by reference; and
13	WHEREAS, the Health and Human Services and the Commerce Committees have reviewed this
14	proposal and recommend approval by the Legislative Council.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
16	Amendment No. 1 substantially in the form attached hereto, and authorizes the
17	Chairwoman of the Nation to execute it.
18	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21 st . Day
19	of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-AGAINST;

21	of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
