

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Gu-Vo District Administration & Communities Budget Amendment
No. 1 and Modification Nos. 1 & 2)

RESOLUTION NO. 06-430

1 **WHEREAS, the Gu-Vo District Governing Council shall not expend District Funds except pursuant**
 2 **to budgets authorized under resolutions of the District Governing Council and**
 3 **approved by the Tohono O'odham Legislative Council (Constitution, Article IX, Section**
 4 **7); and**

5 **WHEREAS, the Tohono O'odham Legislative Council is further vested with the power to "amend**
 6 **annual budgets and to authorize the expenditure of funds in accordance with these**
 7 **budgets" (Article VI, Section 1(d)(2) and (d)(3) of the Constitution of the Tohono**
 8 **O'odham Nation); and**

9 **WHEREAS, pursuant to Resolution No. 05-596, the Legislative Council did approve FY'06 Gu-Vo**
 10 **District Administration and Communities budgets in a total amount of One Million**
 11 **One Hundred Nine Thousand Seven Hundred Ninety Six Dollars and Seventy Three**
 12 **Cents (\$1,109,796.73); and**

13 **WHEREAS, the Gu Vo District Governing Council has adopted resolutions approving budget**
 14 **amendments and modifications for the communities within the Gu-Vo District, which**
 15 **are incorporated by these references, as follows:**

3. the communities of Ali Chugk Community, Pia Oik Community, and Kukatch Community are moving funds around to various line items; bottom line amounts do not change; and

WHEREAS, the Gu-Vo District Administration has submitted the amendments and modifications to the Tohono O'odham Legislative Council Budget and Finance Committee for review and approval; and

WHEREAS, the Tohono O'odham Legislative Council Budget and Finance Committee did review the Gu-Vo District amendments and modifications and recommends approval.


NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves as follows and as per attached budgets:

1. Gu-Vo District Administration Amendment No.1 which includes one new line item and Modification No. 2 (\$25,769.84).
2. Gu-Vo Community Amendment No. 1 which includes three (3) newline items and Modification No. 2 (\$9,618.42).
3. Ali Chugk Community Modification No. 1 (\$10,693.86) moving funds around in various line items.
4. Pia Oik Community Modification No. 2 (\$7,518.39) moving funds around.
5. Kukatch Community Modification No. 1 (\$9,174.00) moving funds around and to cover over expenditures.

BE IT FINALLY RESOLVED that any other amendments or modifications affecting the funding or funding levels of the attached budget shall be submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
