7	District Youth Budget for funding the Youth with Airfare, Room and Board during the
8	Unity Conference; and
9	WHEREAS, a new line item (Travel) needs to be created in the Sif-Oidak District Youth Budget; and
10	WHEREAS, the Sif-Oidak District Council passed Resolution #06-06-03 approving an amendment
11	to the FY'06 Sif-Oidak District Youth Budget; and
12	WHEREAS, a Budget Amendment is attached for review and approval by the Tohono O'odham
13	Legislative Council.
14	NOW, THEREFORE, BE IT RESOLVED that a new line item (Travel) 06-5-7202-660 is created in the
15	Sif-Oidak District Youth Budget.
16	BE IT FURTHER RESOLVED that the FY'06 Sif-Oidak District Youth Budget is increased by
17	\$11,367.91 with a new total of $$17,367.91$ from the final allocation of Gaming Revenues.
18	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council does hereby approve an
19	Amendment to the Sif-Oidak District FY 2006 Budget, increasing the budget by
20	\$11,367.91 and reflecting a grand total of \$1,109,796.73.
