

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment #1/Modification #1 of the Office of the Chairwoman Budget 01-1001)**

**RESOLUTION NO. 06-435**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2006 Office of the**  
2 **Chairwoman budget (01-1001) with Resolution No. 05-558; and**

3 **WHEREAS, the Office of the Chairwoman has requested an Amendment #1/Modification #1 to add**  
4 **additional line items and to increase or decrease the current line items to meet the**  
5 **expenditure trends of the office; and**

6 **WHEREAS, line items 610.5 Other Compensation and 750 Major Capital will be added to the**  
7 **FY2006 Office of the Chairwoman budget; and**

8 **WHEREAS, the FY2006 Office of the Chairwoman budget (01-1001) has been reviewed by the**  
9 **Tohono O'odham Legislative Council Budget and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 11 **1. Approves the creation and addition of the above line items to the FY2006 Office of**  
12 **the Chairwoman budget.**  
13 **2. Authorizes expenditure of funds as presented in the attached budget summary**  
14 **and justification hereto.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
16 **Nation's Officials, to wit: the Chairwoman, Vice Chairman, and any designated official**  
17 **are authorized to administer the budget, provided however, that any amendment**  
18 **affecting the funding or funding levels of the budget shall be submitted for further**  
19 **prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
21 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,861.8 OR; -0- AGAINST;**  
22 **579.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
23 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
