

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Tohono O'odham Ki:ki Association Interim Executive Director)**

**RESOLUTION NO. 06-442**

1 **WHEREAS, the Tohono O'odham Legislative Council is constitutionally vested with all the**  
2 **legislative powers of the Nation, and is specifically vested with the power to enact**  
3 **ordinances "to promote, protect and provide for public health, peace, morals,**  
4 **education and general welfare of the Tohono O'odham Nation and its members"**  
5 **(Constitution of the Tohono O'odham Nation , Article V, Section 1; Article VI, Section**  
6 **1 and Section 1(c)(2)); and**

7 **WHEREAS, the Council did enact Ordinance No. 98-03, "Establishment of Tohono O'odham Ki:ki**  
8 **Association" ("TOKA Ordinance") and thereby established the Tohono O'odham Ki:ki**  
9 **Association ("TOKA") and the position of TOKA Executive Director, which is currently**  
10 **vacant; and**

11 **WHEREAS, pursuant to Resolution No. 06-440, the Legislative Council provided that**  
12 **"notwithstanding Article VI, Section 3 of the TOKA Ordinance, the Legislative Council**  
13 **may appoint an employee of the Nation or other person to temporarily serve as the**  
14 **Ki:Ki Association Executive Director ("Interim Executive Director") for a period not**  
15 **to exceed six months, provided that no Executive Branch employee shall be appointed**  
16 **without the concurrence of the Nation's Chairperson and further provided that the**  
17 **Interim Executive Director shall report to the Legislative Council Housing Committee**  
18 **and, upon request, to the full Legislative Council and the Chairperson of the Nation."**  
19 **and**

20 **WHEREAS, the Legislative Council has delegated to the Legislative Council Housing Committee**  
21 **oversight of housing matters affecting the Nation and its members, including**  
22 **legislative oversight of the TOKA (Legislative Order No. 01-217, "Adoption of Housing**  
23 **Committee Plan of Operation"); and**

24 **WHEREAS, the Housing Committee has consulted with the Nation's Chairwoman, who concurs**  
25 **that Ned Norris, Jr. be appointed as Interim Executive Director, subject to his**  
26 **resignation as Vice Chairperson of the Nation.**

1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**

2 **Ned Norris, Jr. as the TOKA Interim Executive Director, subject to his resignation as**  
3 **the Vice Chairperson of the Nation, provided that**

4 **(1) the Interim Executive Director shall have the powers, duties and responsibilities**  
5 **of the TOKA Executive Director during the term of his appointment;**

6 **(2) the Interim Director shall be compensated at the Executive Director's annual**  
7 **rate of pay (\$71,578);**

8 **(3) the Interim Executive Director shall report to the Legislative Council Housing**  
9 **Committee and, upon request, to the full Legislative Council and the Chairperson**  
10 **of the Nation, but shall be supervised by the Interim Board in accordance with the**  
11 **TOKA Ordinance; and**

12 **(4) the Interim Executive Director's appointment shall expire six months from the**  
13 **effective date of this Resolution except as otherwise provided by subsequent**  
14 **action of the Legislative Council, provided that the Interim Director's**  
15 **appointment shall expire if he is replaced by a permanent Executive Director.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
17 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,103.45 FOR; 1,023.05**  
18 **AGAINST; 314.3 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (c)(2) of Article V and VI, of the Constitution of the Tohono O'Odham Nation, adopted by**  
20 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**




