13 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article II,**  
14 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**  
15 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
17 **18, 1934 (48 Stat. 984).**




