1	WHEREAS,	at a regular Council meeting held on June 10, 2006, the Sif-Oidak District Council,
2		upon review of the FY '07 District Budget motioned to approve the 2.5% Cost of Living
3		increase for the Chairwoman, Vice-Chairwoman and Full time Employees; and
4	WHEREAS,	by Resolution No. <u>06-06-40</u> , the Sif-Oidak District Council approved their FY 2006-
5		2007 Budget in the amount of \$1,353,166.72 at a Special Council meeting held on June
6		24, 2006; and
7	WHEREAS,	the Sif-Oidak District Council does have sufficient funds in their Investment account
8		to implement the Budget amount requested; and
9	WHEREAS,	on July 13, 2006, Sif-Oidak District presented their FY 2007 Budget request in the
10		amount of \$1,353,166.72 including a 2.5% Cost of Living increase for full time
11		employees only per District Resolution No. <u>06-06-25</u> to the Tohono O'odham
12		Legislative Council for their approval.
13	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14		FY 2007 Sif-Oidak District Budget in the amount of \$1,353,166.72 which includes a
15		2.5% Cost of Living increase for full time Employees only per District Resolution No.
16		<u>06-06-25</u> .
17	BE IT FURT	THER RESOLVED that Sif-Oidak District be authorized to utilize their Investment
18		account to expend their FY 2007 District Budget as follows:
19		1. The Investment Reserve Account #7392 be used to fund the FY 07 Budget in the
20		amount of \$1,353,166.72.
21		2. Monthly installments of \$112,763.89 will be deposited in the Operating Account
22		until such time when the Gaming Revenues are distributed by the Tohono
23		O'odham Legislative Council.
24		3. If the "Allocation" of the Gaming Revenues are at or exceeds \$1,353,166.72, then
25		the Investment Reserve Account #7392 will be reimbursed for the full amount
26		expended.
27		4. Any amounts in excess of the budgeted amount will be deposited in the
28		Investment Reserve Account #7392.
