13	budget with a total Direct Cost of \$319,786.47 plus Indirect Cost of \$27,392.30
14	which reflects the current 17.98% negotiated rate = \$347,178.77 Total.
15	2. The Tohono O'odham Nation Officials to wit, the Chairwoman is hereby authorized
16	to negotiate and administer the budget provided however that any amendments
17	affecting the funding or funding levels of this budget shall be submitted for further
18	prior approval by this Council.
