

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval and Authorization of FY 2006 Budget Amendments No. 1 for both TOPD and
TOFD for the Tohono O'odham Nation Department of Public Safety Personnel Retirement
Program Participation with the State of Arizona in the Amount of \$6,414,818.03)**

RESOLUTION NO. 06-479

1 **WHEREAS, by resolution 06-084 which approved the Tohono O'odham Nation's joinder in the**
2 **Arizona Public Safety Personnel Retirement System and appropriated funds from**
3 **gaming savings not to exceed \$6,414,818.03 for payment of the buy in amount which**
4 **was transferred into the General Fund; and**

5 **WHEREAS, the TONDPS has formulated two budget amendments for TOPD and TOFD: Budget**
6 **Amendment No. 1 for TOPD of \$5,470,612.69; and Budget Amendment No. 1 for TOFD**
7 **of \$944,205.33; and**

8 **WHEREAS, these two budgets are for the Actuarial Accrued Liability to 12/31/05 and the calculated**
9 **actuarial for 9 months (01/01/06 to 09/30/06) for the employers contribution of this**
10 **expense; and**

11 **WHEREAS, TONPD and TONFD is requesting approval from the Legislative Council for these two**
12 **budget amendments to be allocated from the General Fund to each of the program's**
13 **budgets under 01-1090 and 01-1095; and**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **(1) Budget Amendment No. 1 for the FY 2006 TONPD tribal budget under Account No.**
16 **01-1090 for the amount of \$5,470,612.69 in one time funding, increasing tribal budget**
17 **total to \$11,707,375.30 and (2) Budget Amendment No. 1 for FY 2006 the TONFD tribal**
18 **budget under Account No. 01-1095 for the amount of \$944,205.33 in one time funding**
19 **increasing tribal budget to \$2,926,353.45 as per attached budgets.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that the Chairwoman**
21 **is authorized to accept, negotiate, and execute any documentation associated with**
22 **exercising the acceptance and implementation of agreement.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
24 **of JULY, 2006 at a meeting at which a quorum was present with a vote of 1,095.4 FOR; 642.6**
25 **AGAINST; -0- NOT VOTING; and 702.8 [14] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


