

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with California Indian Legal Services)

RESOLUTION NO. 06-484

1 **WHEREAS, pursuant to Legislative Council Resolution No. 05-674, the Tohono O'odham Nation**
2 **(the "Nation") entered into an Attorney Contract with California Indian Legal Services**
3 **(the "Attorneys") for the purpose of providing legal representation to the Nation in**
4 **cases arising in the State of California under the Indian Child Welfare Act which**
5 **concern the Nation's interests; and**

6 **WHEREAS, the Attorney Contract is in the amount of \$80,000 for the period from October 1, 2005**
7 **to September 30, 2006; and**

8 **WHEREAS, additional funding is required to continue representation of the Nation by the**
9 **Attorneys under the Attorney Contract; and**

10 **WHEREAS, the Attorney General has proposed Amendment No. 1 to the Attorney Contract which**
11 **increases the Contract amount from \$80,000 to \$100,000; and**

12 **WHEREAS, the budget of the Office of Attorney General (01-1031-810) has sufficient funds for the**
13 **increased Contract amount; and**

14 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval by the**
15 **Legislative Council of Amendment No. 1 to the Attorney Contract.**


16 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**
18 **Attorney Contract, in the form attached hereto, which increases the Contract**
19 **amount from \$80,000 to \$100,000.**
- 20 **2. Funding for Amendment No. 1 shall be provided from the budget of the Office of**
21 **Attorney General (01-1031-810).**
- 22 **3. The Chairwoman of the Nation is authorized and directed to execute Amendment**
23 **No. 1.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
26 **of JULY, 2006 at a meeting at which a quorum was present with a vote of 2,182.1 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and 258.7 [06] ABSENT, pursuant to the powers vested in the Council by Section**
28 **2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
