5	Families provides funds for the continued operation of the Head Start Program; and
6	WHEREAS, the Head Start Program has completed the FY 2007 Head Start Refunding Application
7	to be submitted to the U.S. Department of Health and Human Services, Administration
8	for Children and Families; and
9	WHEREAS, the U.S Department of Health and Human Services, Administration for Children and
10	Families requires a 20% match from awardees made by a combination of cash and in
11	kind contributions; and
12	WHEREAS, the 20% match will be met by a combination of in kind contributions and the approved
13	2007 Tribal Match Budget.
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does
15	hereby approve the submittal of the Tohono O'odham Nation Head Start Fiscal Year
16	2007 Head Start refunding application of \$1,618,399.00 to the U.S. Department of
17	Health and Human Services, Administration for Children and Families.
18	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
19	Nation's officials to wit: the Chairman, and any designated official are hereby
20	authorized to negotiate and execute the grant provided that any amendments
21	affecting the funding or funding levels of this grant shall be submitted for approval by
22	this Council.
