

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Fiscal Year 2007 Head Start Refunding Application)

RESOLUTION NO. 06-492

1 **WHEREAS, the Tohono O'odham Nation has operated a Head Start Program to provide**
2 **educational, health, mental health, and parent involvement services to children,**
3 **three to five years of age; and**

4 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**
5 **Families provides funds for the continued operation of the Head Start Program; and**

6 **WHEREAS, the Head Start Program has completed the FY 2007 Head Start Refunding Application**
7 **to be submitted to the U.S. Department of Health and Human Services, Administration**
8 **for Children and Families; and**

9 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**
10 **Families requires a 20% match from awardees made by a combination of cash and in**
11 **kind contributions; and**

12 **WHEREAS, the 20% match will be met by a combination of in kind contributions and the approved**
13 **2007 Tribal Match Budget.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
15 **hereby approve the submittal of the Tohono O'odham Nation Head Start Fiscal Year**
16 **2007 Head Start refunding application of \$1,618,399.00 to the U.S. Department of**
17 **Health and Human Services, Administration for Children and Families.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation's officials to wit: the Chairman, and any designated official are hereby**
20 **authorized to negotiate and execute the grant provided that any amendments**
21 **affecting the funding or funding levels of this grant shall be submitted for approval by**
22 **this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day**
24 **of JULY, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Article VI,**
26 **Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


