

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Gaming Revenue Distribution Formula Adopted Pursuant to
Resolution No. 94-098, as Amended, to Delete Host District Share)**

RESOLUTION NO. 06-496

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with broad legislative and fiscal powers, including the power "to manage any**
3 **funds within the exclusive control of the Tohono O'odham Nation, including proceeds**
4 **derived from lands and resources of the Tohono O'odham Nation" (Constitution,**
5 **Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the distribution of the Nation's gaming revenues is governed by the formula**
7 **established pursuant to Resolution No. 94-098, "Authorizing Gaming Revenue**
8 **Distribution Formula," as amended; and**

9 **WHEREAS, paragraph 1.b.(ii)(A) of the gaming revenue distribution formula currently provides**
10 **that "Thirty (30%) of the District Allocation shall be allocated to the District where the**
11 **Gaming Facility which generated such revenue is located" ("Host District Share"); and**


12 **WHEREAS, it is in the Nation's best interest to amend Resolution No. 94-098, as amended, to delete**
13 **the Host District Share and allocate the entire District Allocation among all eleven**
14 **Districts of the Nation.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
16 **Resolution No. 94-098, as amended, as follows: paragraph 1.b.(ii) shall be deleted and**
17 **replaced in its entirety to read as follows:**

18 **"(ii) Thirty percent (30%) of such amount (hereinafter referred to as the**
19 **"District Allocation") shall be divided among all eleven Districts of the Nation."**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day**
21 **of JULY, 2006 at a meeting at which a quorum was present with a vote of 1,243.4 FOR; 1,197.4**
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(d) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
