1	WHEREAS, during the July 18, 2006 General Session of the Tohono O'odham Legislative Council
2	the Council did pass Resolution No. 06-500, "Approving FY 2007 Apportionment o
3	Gaming Revenues to Districts by Equal Distribution"; and
4	WHEREAS, upon presentation of Resolution No. 06-500 to the Chairwoman of the Tohono
5	O'odham Nation, she did disapprove thereof and returned it to the Council with he
6	objections in accordance with the provisions of Article VII, Section 5 of the
7	Constitution of the Tohono O'odham Nation; and
8	WHEREAS, during the June 24, 2006 Emergency Session, the Chairwoman presented to the
9	Legislative Council her justification in vetoing Resolution No. 06-500, a copy of which
10	is attached hereto; and
11	WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after
12	consideration, again voted to pass Resolution No. 06-500.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
14	override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance
15	with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odhan
16	Nation.
