

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Utility Authority Queenswell Water Main Extension  
Right-of-Way, Schuk Toak District, Tohono O'odham Nation)**

**RESOLUTION NO. 06-517**

1 **WHEREAS, by Resolution No. 08-70 the Nation established the Papago Tribal Utility Authority, now**  
2 **known as Tohono O'odham Utility Authority (TOUA) for purposes of constructing,**  
3 **maintaining and operating various utility systems within the Nation to be owned**  
4 **wholly by the Nation; and**

5 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 91-175 (Adopting**  
6 **Second Restated Plan of Operation for the Tohono O'odham Utility Authority) which**  
7 **requires the Authority to submit for prior review and approval of the Legislative**  
8 **Council and each affected District any proposed utility easement; and**

9 **WHEREAS, TOUA requests permission for a Water Main Extension Right-of-Way and related**  
10 **facilities for the community of Queenswell, Schuk Toak District, Tohono O'odham**  
11 **Nation; and**

12 **WHEREAS, the requested Water Main Extension Right-of-Way consists of a parcel of land 1,527.00**  
13 **feet in length x 50.00 feet in width which encompasses 1.75 acres more or less; and**

14 **WHEREAS, TOUA has respectfully submitted all documents and pertinent information**  
15 **(incorporated herein by reference) for uses consistent with the authorized purposes**  
16 **of TOUA; and**

17 **WHEREAS, the TOUA Queenswell Water Main Extension Right-of-Way and related facilities will be**  
18 **of substantial benefit to the Queenswell Community, Schuk Toak District, Tohono**  
19 **O'odham Nation and their respective members; and**

20 **WHEREAS, the Schuk Toak District Council did support the Right-of-Way request by enactment**  
21 **of Resolution No. ST-07-08-06-25; and**

22 **WHEREAS, the Natural Resources Committee reviewed the requested Right-of-Way on August 01,**  
23 **2006 and by consensus does recommend further approval thereof by the Tohono**  
24 **O'odham Legislative Council.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
26 **approve the Right-of-Way as requested by TOUA for the Queenswell Water Main**  
27 **Extension and related facilities in the location (as more fully described in the**  
28 **referenced legal description and Right-of-Way Plan) and construction by TOUA or its**  
29 **designated subsidiaries for uses consistent with the authorized purposes of TOUA.**




