

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Fiscal Year 2007 Recreation Division Budget)**

RESOLUTION NO. 06-520

1 **WHEREAS, Initiative IN-01-97 appropriated funds for the construction of five Recreation Centers**
2 **and the first several years of operational costs of the five Recreation Centers; and**

3 **WHEREAS, the Tohono O'odham Nation Recreation Division has prepared a budget in the amount**
4 **of \$2,700,000.00 for FY 2007; and**

5 **WHEREAS, the Recreation Division FY 2007 Budget has been reviewed by the Human Resources**
6 **Development Committee and the Budget and Finance Committee.**


7 **NOW ,THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **authorizes the expenditure of the Tohono O'odham Recreation Division FY 2007**
9 **Budget to be funded by IN-01-97 Youth Initiative appropriated funds.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Council that the FY 2007 Recreation**
11 **Budget is hereby approved for a total amount of \$2,700,000.00**

12 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
13 **O'odham Nation's Official, to wit: the Chairwoman, is authorized to expend the**
14 **attached budget; provided however, that any amendments affecting the funds or**
15 **funding levels of the budget shall be submitted for further prior approval.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
17 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 2,043.6 FOR; -0-**
18 **AGAINST; 210.5 NOT VOTING; and 186.7[03] ABSENT, pursuant to the powers vested in the Council**
19 **by Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
20 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**




