

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the 2nd year funding at \$147,782.37 for the Multi-year Grant under the
Bureau of Justice Administration, Indian Alcohol and Substance Abuse Program
Grant Award No. 2005-AC-BX-0005)**

RESOLUTION NO. 06-521

1 **WHEREAS, the Legislative Council is vested with the authority “[t]o exercise the inherent powers**
2 **of the Tohono O’odham Nation by providing laws, ordinances, and resolutions...(2) to**
3 **promote, protect, and provide for public health, peace, morals, education and general**
4 **welfare of the Tohono O’odham Nation and its members” (Article VI, Section 1 (2), of the**
5 **Constitution of the Tohono O’odham Nation); and**

6 **WHEREAS, the Children’s Program has identified and developed an Intervention Program that**
7 **will educate and promote social awareness and has applied for a multi-year grant**
8 **from the Bureau of Justice Administration in the amount of \$500,000.00; and**

9 **WHEREAS, the program will provide intervention and prevention programs to assist in the**
10 **education and awareness of alcohol and substance abuse-related juvenile crimes;**
11 **traffic fatalities and injuries; produce culturally relevant anti-alcohol/anti-drug**
12 **media messages for the Nation; enlist support and involvement of the Nation’s**
13 **citizens; law enforcement personnel; and other relevant agencies on behalf of at-risk**
14 **youth; and**

15 **WHEREAS, due to the fact that neither of the positions to be hired under the grant was**
16 **accomplished, which also coincided with the end of the federal fiscal year of June 30,**
17 **2006; none of the funds in the amount of \$223,582.89 were expended for FY 2006.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council does hereby**
19 **accept and approve the Indian Alcohol and Substance Abuse Media Message and**
20 **Public Information Campaign Program grant award number 2005-AC-BX-0005 which**
21 **is a three (3) year Grant beginning July 1, 2005 to June 30, 2008 in the combined**
22 **amount of \$500,000.00; and FY July 1, 2006 to June 30, 2007 budget in the amount of**
23 **\$147,782.37.**

24 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council that the Tohono O’odham**
25 **Nation’s official, to wit; the Chairwoman is hereby authorized to negotiate and execute**
26 **the contracts and plans, provided however, that any amendment affecting the funding**
27 **or funding levels of this contract shall be submitted for further prior approval by this**
28 **Council.**






