## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Addendum to FY06 Conflict Attorney Contract for David M. Juarez)

RESOLUTION NO. 06-523

1	WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program
2	is not ethically allowed to handle in the increasing needs of tribal members for legal
3	representation in civil and criminal matters; and
4	WHEREAS, the Advocate Program wishes to increase funding of the existing conflict attorney
5	contract with conflict attorney David M. Juarez to represent clients with conflicts of
6	interest who cannot be represented by the Nation's Advocate Program; and
7	WHEREAS, the Advocate Program has presented an Addendum to the FY06 Conflict Attorney
8	Contract for David M. Juarez which increases the funding of his contract by fifteen
9	thousand dollars, for a total of sixty-five thousand, and which confirms and ratifies the
10	existing terms and conditions related to his services, a copy of which is attached; and
11	WHEREAS, the Domestic Affairs Committee has reviewed the Advocate Program's proposed
12	Addendum to the FY06 Conflict Attorney Contract for David M. Juarez and
13	recommended its submission to the Legislative Council.
14	NOW, THEREFORE, BE IT RESOLVED;
15	1. The Tohono O'odham Legislative Council approves the Addendum to the FY2006
16	Conflict Attorney Contract for David M. Juarez in the form attached hereto for the
17	period of October 1, 2005 through September 30, 2006, increasing the amount of
18	funding for his Conflict Attorney Contract by fifteen thousand (\$15,000.00) dollars
19	for a total not to exceed sixty-five thousand (\$65,000.00) dollars.
20	2. Funding for the increase in the Conflict Attorney contract for David M. Juarez shall
21	be provided under the operating budget of the Advocate Program for fiscal year
22	2006.
23	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $08^{TH}$ . Day
24	of AUGUST, 2006 at a meeting at which a quorum was present with a vote of $1,471.0$ FOR; $421.0$
25	AGAINST; 169.0 NOT VOTING; and 379.8 [07] ABSENT, pursuant to the powers vested in the Council
26	by Section $1(d)(2) & (3)$ and Section $2(a)$ of Article VI of the Constitution of the Tohono O'Odham
27	Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
