

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Addendum to FY06 Conflict Attorney Contract for Lawrence O. Boswell)

RESOLUTION NO. 06-524

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to increase funding of the existing conflict attorney**
5 **contract with conflict attorney Lawrence O. Boswell to represent clients with conflicts**
6 **of interest who cannot be represented by the Nation's Advocate Program; and**

7 **WHEREAS, the Advocate Program has presented an Addendum to the FY06 Conflict Attorney**
8 **Contract for Lawrence O. Boswell which increases the funding of his contract by**
9 **fifteen thousand dollars, for a total of sixty-five thousand, and which confirms and**
10 **ratifies the existing terms and conditions related to his services, a copy of which is**
11 **attached; and**

12 **WHEREAS, the Domestic Affairs Committee has reviewed the Advocate Program's proposed**
13 **Addendum to the FY06 Conflict Attorney Contract for Lawrence O. Boswell and**
14 **recommended its submission to the Legislative Council.**

15 **NOW, THEREFORE, BE IT RESOLVED;**

16 **1. The Tohono O'odham Legislative Council approves the Addendum to the FY2006**
17 **Conflict Attorney Contract for Lawrence O. Boswell in the form attached hereto for**
18 **the period of October 1, 2005 through September 30, 2006, increasing the amount**
19 **of funding for his Conflict Attorney Contract by fifteen thousand (\$15,000.00)**
20 **dollars for a total not to exceed sixty-five thousand (\$65,000.00) dollars.**

21 **2. Funding for the increase in the Conflict Attorney contract for Lawrence O. Boswell**
22 **shall be provided under the operating budget of the Advocate Program for fiscal**
23 **year 2006.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
25 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 1,833.1 FOR; 421.0**
26 **AGAINST; -0- NOT VOTING; and 186.7 [03] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1(d)(2) & (3) and Section 2(a) of Article VI of the Constitution of the Tohono O'Odham**
28 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
30 **of the Act of June 18, 1934 (48 Stat. 984).**


