5	contract with conflict attorney John M. Neis to represent clients with conflicts o
6	interest who cannot be represented by the Nation's Advocate Program; and
7	WHEREAS, the Advocate Program has presented an Addendum to the FY06 Conflict Attorney
8	Contract for John M. Neis which increases the funding of his contract by twenty
9	thousand dollars, for a total of fifty-five thousand, and which confirms and ratifies the
10	existing terms and conditions related to his services, a copy of which is attached; and
11	WHEREAS, the Domestic Affairs Committee has reviewed the Advocate Program's proposed
12	Addendum to the FY06 Conflict Attorney Contract for John M. Neis and recommended
13	its submission to the Legislative Council.
14	NOW, THEREFORE, BE IT RESOLVED;
15	1. The Tohono O'odham Legislative Council approves the Addendum to the FY2000
16	Conflict Attorney Contract for John M. Neis in the form attached hereto for the
17	period of October 1, 2005 through September 30, 2006, increasing the amount o
18	funding for his Conflict Attorney Contract by twenty thousand (\$20,000.00) dollars
19	for a total not to exceed fifty-five thousand (\$55,000.00) dollars.
20	2. Funding for the increase in the Conflict Attorney contract for John M. Neis shall be
21	provided under the operating budget of the Advocate Program for fiscal year 2006
