

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Tohono O'odham Ki:Ki Association Interim Executive Director)

RESOLUTION NO. 06-531

1 **WHEREAS, the Tohono O'odham Legislative Council is constitutionally vested with all the**
2 **legislative powers of the Nation, and is specifically vested with the power to enact**
3 **ordinances "to promote, protect and provide for the public health, peace, morals,**
4 **education and general welfare of the Tohono O'odham Nation and its members"**
5 **(Constitution of the Tohono O'odham Nation, Article V, Section 1; Article VI, Section 1**
6 **and Section 1(c)(2)); and**

7 **WHEREAS, the Council did enact Ordinance No. 98-03, "Establishment of Tohono O'odham Ki:Ki**
8 **Association" ("TOKA Ordinance") and thereby established the Tohono O'odham Ki:Ki**
9 **Association ("TOKA") and the position of TOKA Executive Director; and**

10 **WHEREAS, pursuant to Resolution No. 06-440, the Legislative Council provided that**
11 **"notwithstanding Article VI, Section 3 of the TOKA Ordinance, the Legislative Council**
12 **may appoint an employee of the Nation or other person to temporarily serve as the**
13 **Ki:Ki Association Executive Director ("Interim Executive Director") for a period not to**
14 **exceed six months, provided that no Executive Branch employee shall be appointed**
15 **without the concurrence of the Nation's Chairperson and further provided that the**
16 **Interim Executive Director shall report to the Legislative Housing Committee and,**
17 **upon request, to the full Legislative Council and the Chairperson of the Nation."; and**

18 **WHEREAS, the Legislative Council has delegated to the Legislative Council Housing Committee**
19 **oversight of housing matters affecting the Nation and its members, including**
20 **legislative oversight of the TOKA (Legislative Order No, 01-217, Adoption of Housing**
21 **Committee Plan of Operation"); and**

22 **WHEREAS, the individual being considered by the Legislative Council is not an Executive Branch**
23 **employee and therefore does not require the concurrence of the Nation's Chairperson**
24 **as provided for in Legislative Council Resolution No. 06-440, Amending Ordinance No.**
25 **98-03, "Establishment of Tohono O'odham Ki:Ki Association and Suspending Duties**
26 **and Responsibilities of TOKA Directors", and**

27 **WHEREAS, the Interim Board of Directors and the Legislative Housing Committee have been**
28 **advised that Ned Norris Jr., will no longer be available to serve in the capacity of**


1 **Interim Executive Director beyond the end of the business day August 11, 2006; and**
2 **WHEREAS, the Interim Board of Directors for the Ki:Ki Association have met and discussed with**
3 **the Legislative Housing Committee the recommendation of Renee F. RedDog to the**
4 **position of Interim Executive Director.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**
6 **Renee F. RedDog to replace Ned Norris, Jr. as the TOKA Interim Executive Director**
7 **effective at the end of the business day, on August 11, 2006, provided that:**

- 8 **(1) the Interim Executive Director shall have the powers, duties and responsibilities**
9 **of the TOKA Executive Director during the term of this appointment;**
10 **(2) the Interim Executive Director shall be compensated at the Executive Director's**
11 **annual rate of pay (\$71,578);**
12 **(3) the Interim Executive Director shall report to the Legislative Housing Committee**
13 **and, upon request, to the full Legislative Council and the Chairperson of the**
14 **Nation, but shall be supervised by the Interim Board in accordance with the TOKA**
15 **Ordinance; and**
16 **(4) the Interim Executive Director's appointment shall expire six months from the**
17 **effective date of Legislative Council Resolution No. 06-442 or December 28, 2006**
18 **except as otherwise provided by subsequent action of the Legislative Council,**
19 **provided that the Interim Director's appointment shall expire if replaced by a**
20 **permanent Executive Director.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
22 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 1,574.8 FOR; 736.65**
23 **AGAINST; 129.35 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1 (c)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
