

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the FY 2006 Tohono O'odham Youth Council Budget Amendment #1)**

**RESOLUTION NO. 06-540**

1 **WHEREAS, the Tohono O'odham Legislative Council recognizes the Tohono O'odham Nation**  
2 **Youth Council as the official voice for youth of the Tohono O'odham Nation Youth**  
3 **Council Resolution No. 95-216; and**

4 **WHEREAS, the Tohono O'odham Nation Youth Council has expended the carryover FY 2006 budget**  
5 **of \$57,490.65 and is requesting \$79,000.00 from the Surplus Fund to amend their FY**  
6 **2006 carryover budget to bring it to a total of \$136,490.65; and**


7 **WHEREAS, the Tohono O'odham Nation Youth Council FY 2006 Budget Amendment #1 has been**  
8 **reviewed by the Human Resources Development Committee and the Budget and**  
9 **Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
11 **authorizes the one time appropriation from the Surplus Funding and expenditure of**  
12 **the FY 2006 Tohono O'odham Nation Youth Council Budget Amendment #1 of**  
13 **\$79,000.00 which will bring the FY 2006 Budget total to \$136,490.65.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council and the Tohono**  
15 **O'odham Nation's Officials, to wit; the Chairwoman and any designated Official are**  
16 **authorized to execute this budget, provided however, that any amendment affecting**  
17 **the funds or funding levels of this budget shall be submitted for further prior approval**  
18 **by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
20 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 2,271.8 FOR; -0-**  
21 **AGAINST; 169.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
