

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving & Supporting the Future Boys & Girls Club of the Tohono O'odham Nation
for A Three Year Financial Commitment & Supporting Membership to the
Boys & Girls Club of America)

RESOLUTION NO. 06-541

1 **WHEREAS, within the past six years the Future Boys & Girls Club of the TON and Steering**
2 **Committee has worked diligently to create and establish a quality prevention program**
3 **for the Tohono O'odham Nation's youth in line with a strong mission and solid vision**
4 **while in collaboration with other existing tribal programs; and**

5 **WHEREAS, the Tohono O'odham Nation's Departments are aware of the tremendous need to**
6 **improve services for O'odham youth; and therefore support the Boys & Girls Club of**
7 **America's programs which seek to create an atmosphere for full potential**
8 **development; and**

9 **WHEREAS, the Tohono O'odham Nation Legislative Council adopted Resolution No. 01-452**
10 **recognizing the Boys & Girls Club Steering Committee to fund raise \$200,000 and**
11 **return to the Legislative Council for further approval; and**

12 **WHEREAS, the Tohono O'odham Nation Legislative Council supports the Future Boys & Girls Club**
13 **of the Tohono O'odham Nation to become a Chartered Club of the Boys & Girls Club of**
14 **America in Indian Country, which will enable the Boys & Girls Club of the TON to seek**
15 **and obtain the additional funding; and**

16 **WHEREAS, the Boys & Girls Club of the TON respectfully requests a three-year commitment from**
17 **the Tohono O'odham Nation by fully supporting the Future Boys & Girls Club budget**
18 **of \$200,000 a year for the next three years totaling \$600,000 from the Tohono O'odham**
19 **Nation with the understanding that this three year funding source is a requirement**
20 **from Boys & Girls Club of America in order to become a Nationally recognized Club;**
21 **and**

22 **WHEREAS, the Tohono O'odham Nation will sanction the Club to apply for full Charter Status,**
23 **thereby, allowing the Club to receive funding of \$50,000 for its start-up year and (an)**
24 **automatic annual funding of \$25,000 from Boys & Girls Club of America thereafter;**
25 **furthermore enabling the Boys & Girls Club of the TON to seek the grant opportunities**
26 **available through Boys & Girls Club of America and in Indian Country; and**

27 **WHEREAS, giving the Boys & Girls Club of the TON the ability and authority to go after the Grant**
28 **opportunities specific for Boys & Girls Club in Indian Country on behalf of Boys & Girls**
29 **Club of the TON, as an entity of the Tohono O'odham Nation.**



1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports**
2 **the Future Boys & Girls Club of the Tohono O'odham Nation to become a chartered club**
3 **of the Boys & Girls Club of America in Indian Country.**

4 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
5 **and appropriates from the Surplus Funds, \$200,000.00, to the Boys & Girls Club of the**
6 **Tohono O'odham Nation for the fiscal year 2007 and commits to financially assist for**
7 **fiscal years 2008 and 2009 to promote and enhance the growth of the O'odham youth**
8 **by providing a safe, positive and enriching program for all the Tohono O'odham**
9 **Nation's Youth.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
11 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 1,682.65 FOR; 494.2**
12 **AGAINST; 96.55 NOT VOTING; and 167.4[06] ABSENT, pursuant to the powers vested in the Council**
13 **by Section 1 (d)(2)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
14 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**


