

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the expenditure of the remaining \$760,000.00 from the FY2006 Cultural Center and Museum 50-1516 budget and approving the FY2007 Cultural Center and Museum 50-1516 budget, in the amount of \$760,000.00)**

RESOLUTION NO. 06-543

1 **WHEREAS, the Tohono O'odham Legislative Council authorized the Nation's Cultural Center and**  
2 **Museum as a \$15,191,080.00 capital project with Resolution No. 2000-275; and**

3 **WHEREAS, \$760,000.00 from the FY2006 Cultural Center and Museum 50-1516 budget has not**  
4 **been allocated and is available to cover capital equipment, construction, and**  
5 **professional services costs of the Cultural Center and Museum in FY2007; and**

6 **WHEREAS, the Cultural Center and Museum Administration Office is requesting a FY2007 budget**  
7 **in the amount of \$760,000.00 to complete the construction of the Cultural Center and**  
8 **Museum; and**

9 **WHEREAS, this budget amendment has been reviewed by the Legislative Cultural Preservation**  
10 **Committee and the Legislative Budget and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

12 **1) authorizes the expenditure of the remaining \$760,000.00 from the FY2006 Cultural**  
13 **Center and Museum 50-1516 budget to cover capital equipment, construction, and**  
14 **professional services costs, and**

15 **2) approves the FY2007 Cultural Center and Museum 50-1516 budget, in the amount**  
16 **of \$760,000.00, in accordance with the budget attached hereto.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**  
19 **to execute the budget, provided however, that any amendments affecting the funds or**  
20 **funding levels of the budget be submitted for further approval by the Tohono O'odham**  
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day**  
23 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 1,842.75 FOR; 598.05**  
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**
