RESOLUTION NO. 06-544

1 **WHEREAS, Initiative IN-01-97, Account No 24-1810 requires that the Nation provide for the**
2 **annual administrative cost of implementing the provisions of the initiative with**
3 **Resolution No. 05-582; and**

4 **WHEREAS, a reserve was established to fund the necessary administrative requirements; and**

5 **WHEREAS, the Executive Branch has prepared a Fiscal Year 2006 budget to continue its**
6 **Initiative Administration; and**

7 **WHEREAS, the Enrollment Program is charged with maintaining a system of tracking the**
8 **membership of the Nation to provide accurate information to the Accounting**
9 **Department for the purpose of accurate fund distribution for per capita payments;**
10 **and**

11 **WHEREAS, the Enrollment Program is requesting additional funds in the amount of \$18,804.00**
12 **to support the associated cost to process the adult verification forms required**
13 **before the Initiative Third Per Capita payment can be distributed to members of the**
14 **Nation; and**

15 **WHEREAS, line item 850 Food will be added to the FY06 Initiative Administrative Enrollment**
16 **Payment Roll budget for cost associated with the third per capita verification; and**

17 **WHEREAS, the budget has been presented to the respective Legislative Oversight Committees**
18 **for review.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
20 **and authorizes the Fiscal Year 2006 Initiative Administrative budget 24-1810**
21 **Amendment No. 1 to add \$18,804.00 from the Desert Diamond savings to increase**
22 **the Enrollment Payment Roll budget to a total amount of \$258,272.49 on a one time**
23 **basis for costs associated with the third per capita payment verification.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
25 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1(d)(2) of Article VI, of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


