RESOLUTION NO. 06-545

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2006 Initiative Admin**
2 **Accounting G/L 24-1807 pursuant to Legislative Council Resolution No. 05-531; and**

3 **WHEREAS, the Nation's Executive Office has requested an additional appropriation from Desert**
4 **Diamond Savings for the FY2006 Initiative budget 24-1807 in the amount of**
5 **\$415,000.00; and**

6 **WHEREAS, line item 830 AUDIT will be added to the FY06 Initiative Admin Accounting G/L Budget**
7 **for costs associated with the minor account audit; and**

8 **WHEREAS, an additional \$415,000.00 will be added to the FY2006 Initiative Admin Accounting G/L**
9 **Budget 24-1807 for a total budget amount of \$510,064.68; and**

10 **WHEREAS, the FY06 Initiative Admin Accounting G/L 24-1807 Budget Amendment #1 has been**
11 **reviewed by the Budget and Finance Committee; and**

12 **WHEREAS, in the event that all costs associated with the minor account audit is not completed by**
13 **September 30, 2006, authorization is requested to carry forward unexpended funds**
14 **to complete the minor account audit in fiscal year 2007.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 16 **1. Approves the addition of line item 830 AUDIT to the FY06 Initiative Admin**
17 **Accounting G/L budget 24-1807 on a one-time basis for FY06 for costs associated**
18 **with the minor account audit.**
- 19 **2. Authorizes the appropriation and expenditure of the Desert Diamond Savings, in**
20 **the amount of \$415,000.00 for a total amount of \$510,064.68 in accordance with**
21 **the budget attached hereto.**
- 22 **3. Authorizes to carry forward funds to FY2007 to continue and complete the minor**
23 **account audit in the event that it is not complete by September 30, 2006.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**
26 **to administer the budget, provided however, that any amendments affecting the funds**
27 **or funding levels of the budget shall be submitted for further prior approval by the**
28 **Tohono O'odham Legislative Council.**


