

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Submittal and Negotiation of the Fiscal Year 2007 Annual Funding
Agreement Proposal to the Bureau of Indian Affairs Indian Self-Determination
Act Master Contract)**

RESOLUTION NO. 06-548

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Bureau of Indian Affairs pursuant to authority conferred to the Nation by the Indian**
3 **Self-Determination Act, Public Law 93-638, as amended; and**

4 **WHEREAS, the Tohono O'odham Nation desires to continue operation of such functions; and**

5 **WHEREAS, the Tohono O'odham Nation is not adding any new programs this year, but during**
6 **FY2007 will close the Employment Assistance program (also known as Job Placement**
7 **and Training) in the BIA 638 Master Contract and will utilize all new FY2007 funds for**
8 **Employment Assistance in a new P.L. 102-477 Program integrating employment**
9 **programs that are now under the Bureau of Indian Affairs, the U.S. Department of**
10 **Labor and the U.S. Department of Health and Human Services, which new program will**
11 **be administered through the Central Office of the Bureau of Indian Affairs; and**

12 **WHEREAS, the Budget and Finance Committee has reviewed the Annual Funding Agreement**
13 **proposal for FY 2007 attached hereto, and recommends approval by the Legislative**
14 **Council.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **attached Bureau of Indian Affairs Annual Funding Agreement proposal for FY 2007,**
17 **and authorizes the Chairwoman of the Nation to submit the Annual Funding**
18 **Agreement to the Bureau of Indian Affairs, to negotiate maximum funding and**
19 **acceptance by the Bureau of Indian Affairs of the terms and conditions contained**
20 **therein, and to execute the Annual Funding Agreement upon completion of the**
21 **negotiations.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
23 **of AUGUST, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**


