## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Amending Budget and Finance Committee Plan of Operation)

RESOLUTION NO. <u>06-549</u>

1	WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules
2	and procedures to regulate all meetings of the Tohono O'odham Council, standing
3	committees, boards, and special committees pursuant to the Constitution of the
4	Tohono O'odham Nation, Article VI, Section 1(a) and (b); and
5	WHEREAS, in 1988 the Legislative Council did adopt a "Plan of Operation for Budget and Finance
6	Committee" by Resolution No. 83-88; and
7	WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,
8	"No district council shall expend district funds except pursuant to budgets authorized
9	under resolutions of the district council and approved by the Tohono O'odham
10	Council."; and
11	WHEREAS, in response to questions concerning the process for approving and modifying district
12	budgets, the Budget and Finance Committee has drafted amendments to its Plan of
13	Operation that would (1) expressly allow districts, like the Nation's departments, to
14	obtain approval of budget modifications without a Legislative Council resolution and
15	(2) make additional amendments to clarify the budget process; and
16	WHEREAS, the Rules Committee has reviewed the amended Budget and Finance Committee Plan
17	of Operation.
18	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
19	amends the Budget and Finance Committee Plan of Operation in accordance with the
20	attached Budget and Finance Committee Plan of Operation dated December 2005.
