8	2006 requiring all district budgets of the Nation to be reviewed by the committee; and
9	WHEREAS, the Sells District still has questions and the committee has not responded nor have
10	they issued a standard format for the district to follow; and
11	WHEREAS, the Sells District by Resolution #SD-29-06 still had questions regarding what role the
12	Budget and Finance committee have in the district budgets passed a resolution to
13	rescind the adopted revised plan of operations; and
14	WHEREAS, the Sells District Council feels the district vote was misrepresented during the passage
15	of Resolution # 06-549; and
16	WHEREAS, the Sells District Council is requesting to the Tohono O'Odham Legislative Council to
17	rescind Resolution # 06-549 "Amending the Budget and Finance Committee Plan of
18	Operations", in it's entirety; and
19	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
20	rescinds resolution # 06-549, "Amending Budget and Finance Committee Plan of
21	Operation", in it's entirety.
