

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2007 Schuk Toak District Budget)

RESOLUTION NO. 06-584

1 **WHEREAS, the Schuk Toak District presented to the Tohono O'odham Legislative Council the**
2 **District's FY07 Budget for the fiscal year; and**

3 **WHEREAS, the Schuk Toak District was allocated Gaming Revenue in the amount of**
4 **\$1,094,690.94; and**

5 **WHEREAS, the Schuk Toak District Council at a meeting held on September 6, 2006 with a**
6 **quorum present, did review and approve the District FY07 Budget in the total**
7 **amount of \$1,061,630.21 per the attached resolutions; and**

8 **WHEREAS, the total budget amounts for each of the following communities as part of the total**
9 **FY07 District Budget are as follows:**

20 **and the total budget amount for all nine (9) communities is \$437,211.71; and**

21 **WHEREAS, the district's Summer Youth Program Budget for FY07 is in the amount of \$74,816.00;**
22 **and**

23 **WHEREAS, the district's Administration Budget for FY07 is in the amount of \$549,602.50; and**

24 **WHEREAS, the combined FY07 district Administration, Summer Youth Program and (9)**
25 **Community budget totals of \$1,061,630.21; and**

26 **WHEREAS, the remaining Gaming Revenue distribution balance to the Schuk Toak District in**
27 **the amount of \$33,060.73 is allocated for the specific purpose of audit compliance**
28 **activity for the district upon submission of a budget amendment at a later date.**


29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
30 **the Schuk Toak District FY07 Budget in the amount of \$1,061,630.21 utilizing FY07**
31 **Gaming Revenue Distribution funds as detailed in the attached documents and**

1 incorporated within this resolution as presented to be expended in accordance with
2 the attached budgets.

3 **BE IT FURTHER RESOLVED** that the remaining balance of \$33,060.73 from the Gaming Revenue
4 distribution for FY07 will be allocated for district audit compliance activity and a
5 budget for expenditure of the balance will be brought forward for approval by the
6 Tohono O'odham Legislative Council at a later date.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
8 of **SEPTEMBER, 2006** at a meeting at which a quorum was present with a vote of 1,917.7 FOR; -0-
9 **AGAINST**; 523.1 NOT VOTING; and [04] **ABSENT**, pursuant to the powers vested in the Council by
10 Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
11 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat. 984).


