9	of \$159,984.29; and
10	WHEREAS, the Water Projects Office requests from the Tohono O'odham Legislative Council,
11	approval of funding from the SAWRSA Trust Fund to enable completion of tribal
12	responsibilities and obligations related to utilization of Central Arizona Project water
13	and irrigation systems in the eastern Schuk Toak District.
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
15	approves the funding request and authorizes the expenditures in the amount of
16	\$159,984.29 to complete tasks indicated in the attached budget for the fiscal year 2007.
17	BE IT FINALLY RESOLVED that funds in the amount of \$159,984.29 are hereby appropriated from
18	the SAWRSA Trust Fund to cover expenditures during the period from October 1, 2006
19	through September 30, 2007.
