

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Extension of Time for Bureau of Reclamation Grant Agreement**  
**No. 01-NA-32-00200 and Budget Modification for Water Projects Office**  
**Equipment Purchase for Schuk Toak New Farm Development)**

**RESOLUTION NO. 06-591**

1 **WHEREAS, the Tohono O'odham Nation ("Nation") did previously approve under Resolution No.**  
2 **01-318, a Grant Agreement ("Agreement") No. 01-NA-32-00200 with the Bureau of**  
3 **Reclamation for an amount of \$335,027.00 to finance the purchase of major**  
4 **equipment needed to maintain and operate the water distribution system at the Schuk**  
5 **Toak New Farm Development; and**

6 **WHEREAS, the current expiration date of Grant Agreement No. 01-NA-32-00200 is June 30, 2006;**  
7 **and**

8 **WHEREAS, the Nation's Water Projects Office has already purchased the heavy equipment**  
9 **identified in the Agreement including the motor grader, backhoe loader, spider**  
10 **sprayer, two (2) vehicles and a tire changer leaving funds available to purchase**  
11 **additional equipment to be specified at a later date as provided for in the Agreement;**  
12 **and**

13 **WHEREAS, the Water Projects Office, in consultation with Schuk Toak Farm, has finalized the**  
14 **specification of additional equipment that can be purchased with the remaining funds**  
15 **from the Agreement, as identified on the attached list; and**

16 **WHEREAS, the Water Projects Office and the Bureau of Reclamation have agreed to an extension**  
17 **of time of the Agreement for an additional nine months until June 30, 2007 to allow**  
18 **time for the purchase of the additional equipment; and**

19 **WHEREAS, the Water Projects Office has also submitted a budget modification to move funds**  
20 **within its budget to provide for the purchase of the remaining equipment needed for**  
21 **the Schuk Toak New Farm Development in the amount of \$46,761.81, as identified on**  
22 **the attached budget modification; and**

23 **WHEREAS, the Water Projects Office has presented the Agreement extension request and budget**  
24 **modification request to the appropriate oversight committees which recommend**  
25 **approval by the Legislative Council.**

26 **NOW THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 27 **1. Approves an extension of time of Bureau of Reclamation Grant Agreement No. 01-**  
28 **NA-32-00200 for an additional nine months until June 30, 2007, and grants**






