

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Chukut Kuk District FY 2007 Budget)

RESOLUTION NO. 06-596

1 WHEREAS, the Chukut Kuk District Council did meet on August 12, 2006 in Vamori at which a
2 quorum was present; and

3 WHEREAS, the District Council did approve the FY 2007 Chukut Kuk District Budget in the
4 amount of \$1,270,986.52 by resolution no. 2006-47 attached hereto and incorporated
5 herein by this reference; and

6 WHEREAS, the FY 2007 District Budget has been presented to and reviewed by the Tohono
7 O'odham Legislative Council Budget & Finance committee.


8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
9 and authorizes expenditure of funds for the Chukut Kuk District FY 2007 budget in
10 the amount of \$1,270,986.52 attached hereto and incorporated herein by this
11 reference.

12 BE IT FURTHER RESOLVED that the difference of \$176,295.58 will be funded from Chukut Kuk
13 District savings.

14 BE IT FINALLY RESOLVED that any amendments affecting the funding levels of the Chukut Kuk
15 District FY 2007 budget shall be submitted for prior approval by the Tohono O'odham
16 Legislative Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
18 of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,486.0 FOR; 362.0
19 AGAINST; 592.8 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
20 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
21 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
23 18, 1934 (48 Stat. 984).




