

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Establishment of a Checking Account at Bank of America for Third Per
Capita Distribution for Adult Members)

RESOLUTION NO. 06-598

1 **WHEREAS, on June 28th, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**
7 **distribution payments in accordance with the Initiative (Legislative Council**
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan**
10 **pursuant to Legislative Council Resolution No.06-307; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Third Per Capita**
12 **Revenue Allocation Plan on July 28, 2006; and**

13 **WHEREAS, authorization is requested to establish a checking account for the Third Per Capita**
14 **Distribution at Bank of America.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves and**
16 **authorizes the Office of the Treasurer to establish a checking account for the Third**
17 **Per Capita Distribution at Bank of America, pursuant to the terms of the Third Per**
18 **Capita Revenue Allocation Plan.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
20 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




