

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2007 Budget)

RESOLUTION NO. 06-602

1 WHEREAS, the Tohono O'odham Legislative Council passed Resolution #06-509 "Approving FY
2 2007 Apportionment of Gaming Revenues to Districts by Equal Distribution, to Clarify
3 FY 2007 District Apportionment Amounts" to distribute funds to the Districts for
4 equal distribution with an amount of \$1,094,690.94; and

5 WHEREAS, the Gu Achi District Council established a quorum at a scheduled special meeting in
6 the Community of Santa Rosa on Monday, September 11th, 2006 to address issues
7 regarding the district; and

8 WHEREAS, the Gu Achi District Council met and addressed the issue of the needs in the District
9 and communities; and

10 WHEREAS, the District Administration and communities budgets were submitted and approved
11 as follows, by District resolution # 0609-236.

28 automatically be deposited to the District's savings account at the Chase Bank.

29 BE IT FINALLY RESOLVED that Gu Achi District reserves the right to modify its Fiscal Year 2007
30 budget(s), but any amendments affecting the funds or funding levels shall be
31 approved by the Legislative Council.

32 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day
33 of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,399.25 FOR; 718.4
34 AGAINST; 323.15 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
35 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
36 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
37 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
38 18, 1934 (48 Stat. 984).
