

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing Tohono O'odham Nation Delegation to the National Congress  
of American Indians 63<sup>rd</sup> Annual Session)**

**RESOLUTION NO. 06-603**

1 **WHEREAS, the National Congress of American Indians ("NCAI") will hold its 63<sup>rd</sup> Annual Session**  
2 **in Sacramento, California on October 2-6, 2006; and**

3 **WHEREAS, the Tohono O'odham Nation is a long-time member in good standing with the**  
4 **National Congress of American Indians; and**

5 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to renew its membership in the**  
6 **National Congress of American Indians.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
8 **it hereby authorizes Nation's Chairwoman Vivian Juan-Saunders, Legislative Council**  
9 **Chairperson Evelyn Juan Manuel, and Legislative Council Representative Timothy**  
10 **Joaquin to attend and serve as the Tohono O'odham Nation's delegation to the**  
11 **National Congress of American Indians 63<sup>rd</sup> Annual Session.**

12 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
13 **Chairwoman Vivian Juan-Saunders as the Tohono O'odham Nation's voting delegate**  
14 **and Legislative Council Chairperson Evelyn Juan Manuel to serve as alternate voting**  
15 **delegate to the National Congress of American Indians 63<sup>rd</sup> Annual Session.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
17 **payment of \$5,000 for NCAI membership dues for the Tohono O'odham Nation.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
19 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,254.1 FOR; -0-**  
20 **AGAINST; 186.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
